Venues NSW (VNSW) host the biggest and best sporting and live entertainment events for the people of NSW. Its \$4bn network of eight stadiums and entertainment centres encompassing Accor Stadium, the Sydney Cricket Ground, Allianz Stadium, Commbank Stadium as well as stadiums and entertainment centres in, Newcastle and Wollongong, host five million people a year at more than 500 events, generating annual operating revenue of circa \$205m. VNSW is a self-funded agency of the NSW Government and governed by a Board.

The CFO leads a cross-functional team including finance, technology and procurement and proactively manages the financial position of VNSW. The role is both commercially focused to create revenue, maximise returns and provide the safeguards and transparency required in a government context.

Overview:

Our story begins in 1852 when the Sydney Cricket Ground was established by British troops stationed at the nearby Victoria Barracks.

Today, and through the formation of Venues NSW in December 2020, we continue that legacy as custodians of the most significant sporting and entertainment precincts in NSW – all within a short distance of more than 80 per cent of the State's population, and in the heart of the Newcastle-Sydney-Wollongong cultural, social and economic belt that drives eastern Australia.

Over the years, our venues have hosted the biggest sporting and live entertainment events in the world, including the Sydney 2000 Olympic Games, the 1938 Empire Games, multiple World Cup fixtures, grand finals, Tests and interstate matches, as well as visits by the biggest names in world sport and entertainment from Muhammad Ali, Don Bradman, Betty Cuthbert, Cathy Freeman and Maradona to Adele, U2 and Ed Sheeran.

We care for and operate our five distinct precincts, six stadiums and two entertainment centres for and on behalf of the people of NSW. Venues NSW is a NSW Government agency which works closely with partner agencies, the private sector, sports partners, and charity and community partners to reinforce NSW's position as Australia's premier state and build its reputation around the world.

Venues NSW is a major employment, tourism, social and economic engine of growth for NSW and Australia. The Venues NSW network comprises more than \$4bn of public community assets, which host some 500 major sport and entertainment events in undisrupted years, attracting upwards of five million attendees each year.

In Sydney, Venues NSW owns the Sydney Cricket Ground and Sydney Football Stadium in Eastern Sydney, ANZ Stadium and CommBank Stadium in Western Sydney, on behalf of the NSW Government.

In the Illawarra, it owns WIN Sports and Entertainment Centres.

In the Hunter, Venues NSW owns McDonald Jones Stadium, and the Newcastle Entertainment Centre and Showground. Venues NSW has developed A Vision for the Hunter Sports & Entertainment Precinct – a long-term plan for a sustainable, exciting sporting and entertainment precinct for Greater Newcastle.

Our Venues:

Accor Stadium

Accor Stadium is a multi-purpose outdoor stadium in Sydney Olympic Park and is operated by VenuesLive Management Services on behalf of Venues NSW.

It opened in 1999 in time for the 2000 Olympics. Built as an oval to host more than 110,000 athletics spectators, a reconfiguration of the Stadium in 2003 reduced capacity to 83,500 including 18,000 stadium Members, and 6,000 corporate seats.

Stadium Australia hosts some of Australia's biggest rectangular code matches including the State of Origin, the NRL Grand Final and the Bledisloe Cup, and is NSW's premier outdoor concert venue for the world's biggest entertainment. The Stadium has set international and Australian attendance records with some 25 million fans sharing in the excitement of great events and iconic sporting moments.

CommBank Stadium

Opened in April 2019, <u>CommBank Stadium is</u> a new 30,000 seat stadium in Parramatta made for the fans. The stadium brings fans closer to the action featuring the steepest grandstands in Australia and creating an awesome live event experience.

CommBank Stadium will deliver a range of events that will engage communities across NSW and is the long term home of the Parramatta Eels (NRL) and the Western Sydney Wanderers (A-League).

McDonald Jones Stadium

McDonald Jones Stadium in Newcastle is a multi-purpose outdoor stadium which seats up to 33,000 spectators and includes a 500-capacity function centre. Opened in 1970, it underwent major grandstand additions in 2005 and 2011, and a pitch upgrade in 2014. It is a multi-sport event venue, with the rectangular field accommodating international standard rugby league, rugby union and football.

McDonald Jones Stadium is the centrepiece of a sports precinct that includes the Newcastle International Hockey Centre and Newcastle International Paceway. It is home to the Newcastle Knights (NRL) and the Newcastle Jets (A-League).





Newcastle Entertainment Centre and Showground

Newcastle Entertainment Centre and Showground are operated by ASM Global on behalf of Venues NSW. The Entertainment Centre has a capacity of up to 7,500 spectators and a flexible configuration that allows for concerts, sports, exhibitions and conferences.

The Showground features a show ring with seating for 3,000 people, an exhibition pavilion and stables. It is home to the annual Newcastle Regional Show and the regular Newcastle Farmer's Market, and is also used for a range of exhibitions, sales and shows.

Sydney Cricket Ground

The <u>Sydney Cricket Ground (SCG)</u> one of Australia's premier sporting and entertainment venues. It boasts an impressive list of credentials, encompassing Cricket, Australian Rules Football, Rugby League, Rugby Union, Football, and even Baseball and Cycling, as well as major concerts.

The primary tenants at the SCG is Cricket (Internationals, Sydney Sixers & NSW Blues), the Sydney Swans (AFL) and currently the Sydney Roosters (NRL) and NSW Waratahs (Super Rugby) while the Sydney Football Stadium is being rebuilt.

Sydney Football Stadium

The NSW Government is redeveloping the <u>Sydney Football Stadium</u> into a modern, world-class, 42,500 seat venue, to ensure Sydney has a sporting and entertainment precinct of international standard and that NSW remains the number one choice for sporting and entertainment events. This stadium opens in September 2022.

Investing in a new state-of-the-art stadium at Moore Park will drive growth in the visitor economy, promote a strong culture and sporting sector, and make NSW more liveable.

WIN Sports Stadium and Entertainment Centres

These two Wollongong venues provide the Illawarra community with exceptional sports and event spaces. WIN Stadium has a capacity of 23,000 spectators and facilities include a function centre for social and business events.

The WIN Entertainment Centre is a multi-purpose arena. The main auditorium has a capacity of 6,000 with flexible configurations for hosting concerts, dinners, seminars, conferences, school formals and exhibitions.

Strategic Initiatives

Hunter Sports & Entertainment Precinct (Hunter Park)

Venues NSW released A Vision for the Hunter Sports and Entertainment Precinct (Concept Plan) on 5 July 2017 for public consultation, inviting feedback on early concept designs for the vision of a sustainable, exciting sporting and entertainment precinct for Greater Newcastle. The consultation period closed on 30 November 2017 and resulted in 465 total submissions. Feedback received during consultation is now informing the next steps in the project, which is the development of a detailed concept plan and business case.

In June 2021, the NSW Government announced funding of \$6.7m for Venues NSW to develop the masterplan and Final Business Case for Hunter Park.





The Board

The Venues NSW Board consists of 12 members who bring a wealth of experience, business acumen and expertise in running the biggest and best sport events and venues.

The Board is responsible for strengthening NSW's position as Australia's number one destination for live sport and entertainment, with a strong focus on attracting the highest quality international and domestic events to New South Wales.

Tony Shepherd AO | Chairman

Term commenced 1 December 2020

Tony is a leading infrastructure and development authority and one of Australia's most highly respected and passionate business leaders. He is also a highly influential advisor to leaders in the public and private sectors. He is Chairman of the AFL's GWS Giants, and he sits on numerous corporate boards.

Rod McGeoch AO | Deputy Chairman

Term commenced 1 December 2020

Rod is one of Australasia's most influential directors. He was the chief executive of Sydney's successful bid for the 2000 Olympic Games. He has had an impressive career in business, sports administration and the legal profession. Rod sits on a number of boards, including Destination NSW and Chubb Insurance Australia. He has an impressive record of bidding and delivering major international sporting and cultural events in Australia and internationally. He has published two books: McGeoch and The Bid.

She was previously a member of the Advisory Boards for the North West rail project and Sydney Light Rail and was a foundation member of the Board of Sydney Metro.

Venues NSW (VNSW) is a commercially focused agency of the NSW Government encompassing the Sydney Cricket Ground and Allianz Stadium, as well as major sporting and entertainment venues and precincts in Sydney Olympic Park, Parramatta, Newcastle and Wollongong. This network of eight stadiums and entertainment centres host five million people a year at more than 500 events and is a key contributor to the NSW economy.

The role is based at the Moore Park headquarters and has responsibilities across the network for sustainable whole of business cashflow, implementation of new whole of business systems and automated reporting, business insights including new funding initiatives and challenge performance of contractors to drive improved business performance.

Even though VNSW operates as a Public Non-Financial Corporation under NSW Treasury's Commercial Policy Framework, we are self-funded and governed by a Board which determines the policies and strategic plans of the agency and sets annual budgets and performance criteria. This role plays a critical role in ensuring the Board is provided with essential financial, risk, and governance information to identify priorities and set the path to a smarter future.

Purpose of the Role

While the traditional responsibilities for directing, controlling, and administering all financial activities remain, this role has a contemporary portfolio to determine future strategy by understanding the value creation process of the business ensuring senior financial team members are properly trained in business strategy and equipped with modern business tools to record the value created, analyse what drives value and control any leakage of value.

Essentially this means tracking cash flow and financial planning, analysing the financial strengths and weaknesses and proposing strategic direction. A major component of the role includes working with the CEO and the Board on transformational initiatives for the organisation.

The role also assists the CEO and venue-based management teams to develop and implement corporate strategy including capital allocation to maximise the commercial business outcomes and ensure the financial sustainability of the business.

VNSW has an asset portfolio of approximately \$2.6bn (which will increase with the redevelopment of Sydney Football Stadium and further venue acquisitions) and debt of approximately \$500m. Operating annual revenue (normalised for COVID-19) is circa \$205m. The CFO proactively manages the financial position of VNSW and is both commercially focused to create revenue, maximise returns and provide the safeguards and transparency required in a government context.
